Item #1 Mayor Duvall called the meeting to order.

Item #2 Invocation was given by Alderman Leonard Johnson.

Item #3 The Pledge of Allegiance was recited.

Item #4 Officials Present: Mayor Donna Duvall, Aldermen Leonard Johnson, Ray Blanchard, Damon Johnson, BJ Bjornberg, Town Clerk Melissa Davis, Chief of Police Delbert Keel, and Town Attorney Steven Oxenhandler.

Item #5 Mayor Duvall honored the Rosepine Volunteer Fire Department, Vernon Parish Police Jury, Rosepine United Pentecostal Church, and The Church of Rosepine, individually by presenting them plaques for contributing in many ways during hurricane Harvey.

Item #6 Alderman Damon Johnson made a motion to accept the minutes from the November 9, 2017 regular meeting and December 5, 2017 special meeting. Seconded by Alderman Ray Blanchard. All I's.

Item #7 Mayor Duvall thanked everyone for attending the meeting and updated everyone on what has been happening in the town along with the events that will be taking place around the area.

Item #8 Alderman Damon Johnson made a motion that was seconded by Alderman Bjornberg to accept the financial reports ending November 30, 2017. All I's.

Item #9 A motion was made by Alderman Bjornberg and seconded by Alderman Blanchard to adopt Resolution #24 of 2017 (Vernon Parish Police Jury Resolution for January 2018) with the addition of "install culverts and build up access to Rosepine Historical Park". All I's.

Item #15 A discussion was held concerning an alternate exit off of Fagan Circle on to Duett Street for the Rosepine Volunteer Fire Department when a train is blocking the Hwy. 171 exit. A discussion was held. During the discussion it was mentioned that Attorney Max Anthony had worked on the issue of right of way in this area and Attorney Oxenhandler stated he would check into what Mr. Anthony had found out.
