

**MINUTES

Item #1 Mayor Donna Duvall called the meeting to order at 6:30 pm.

Item #2 Invocation was given by Alderman Ray Blanchard.

Item #3 The Pledge of Allegiance was recited.

Item #4 Officials present: Mayor Donna Duvall, Aldermen BJ Bjornberg, Damon Johnson, Ray Blanchard, and Town Clerk Melissa Davis.

Absent was: Aldermen Jeff Solinsky and Leonard Johnson

Item #5 Alderman Damon Johnson made a motion to accept the minutes from the March 21, 2023 regular meeting as presented. Seconded by Alderman BJ Bjornberg. All I's.

Item #6 Mayor Duvall welcomed everyone. She stated that a decision was made to put off the public hearing concerning the reconstruction of Main Street until all the board could be present.

Item #7 Alderman Damon Johnson made a motion to accept the financial reports ending March 31, 2023 as presented. Seconded by Alderman BJ Bjornberg. All I's.

Item #8 A motion was made by Alderman Damon Johnson that was seconded by Alderman BJ Bjornberg to adopt Resolution #7 of 2023 (Vernon Parish Police Jury Resolution for the month of May 2023) with the addition of requesting assistance with clearing limbs that are hanging over the street on the corner of Cedar Steet and Highway 171 and replacing the culverts located near 7152 Main Street. Item #9 Alderman Damon Johnson made a motion that was seconded by Alderman BJ Bjornberg to declare the 2003 Chevy C15 and 2009 Chevy Tahoe as surplus and send them to auction. All I's.

Item #10 A motion was made by Alderman Damon Johnson to adopt Resolution #8 of 2023 (Accept potable water and sanitary sewer improvements upon completion of the Evans Street Subdivision). Seconded by Alderman Ray Blanchard. All I's.

Item #11 Mayor Duvall updated the board on the past plans to put a "Welcome to the Town of Rosepine" sign up. A lengthy discussion was held concerning what type of sign to put up.

Alderman Damon Johnson made a motion to table the item until the next regular meeting when the board will have more information. Seconded by Alderman Ray Blanchard. All I's.
